

TERMS AND CONDITIONS

Please review these terms and conditions carefully as they apply to your participation at SARRAH 2024.

By attending, speaking, exhibiting, or sponsoring at SARRAH 2024, you agree to the Terms and Conditions set out below, which form a legally binding agreement between you and the Conference host – Services for Australian Rural and Remote Allied Health.

PAYMENT OF REGISTRATION

The payment of the registration is either by credit card or bank transfer at the time of registration. A registration is considered complete when full payment is received by the host organisation.

The Australian goods and services tax (GST) at 10% is applicable to all goods and services offered by the Conference. All registration fees listed are inclusive of GST.

DISCOUNTED REGISTRATION FEES

Early Bird registration fees

To qualify for early bird registration, registration fees must be paid in full by Friday 28 June 2024. If registration fees have not been received by Friday 28 June 2024 your registration will revert to the standard Conference registration fee.

Registration fees are based on date of payment receipt, not the date of receipt of registration form.

SARRAH Member Registration

Members of SARRAH are eligible to register for SARRAH 2024 at a discounted rate. This rate will also extend to delegates who purchase SARRAH membership prior to registration and are subject to the Terms and Conditions of SARRAH membership.

Day Registration

Delegates can only purchase ONE day registration. If more than one day registration is required, then a FULL registration must be purchased.

Presenter Registration

Delegates who are confirmed as a Presenter at SARRAH 2024 will be eligible to purchase their ticket at a Presenter Registration rate. Any non-eligible purchases under the Presenter Registration rate will be automatically revered to the standard Conference registration fee and will be deemed an incomplete registration until full payment is complete.

Student Registration

Student registration is reserved for those who are SARRAH Student Members. Any non-eligible purchases under the Student Registration rate will be automatically revert to the standard Conference registration fee and will be deemed an incomplete registration until full payment is complete.

TRANSFER OF REGISTRATION

All fully paid registrations are transferable to other persons from the same organisation. Transfers can be made by the registered person in writing to the Conference Organising Committee at conference@sarrah.org.au no later than Friday 30 August 2024. Details must include the full name of the replacement person, their title, contact phone number and email address. All other registration details will be carried over to the new person unless otherwise specified. Transfer of registrations to another person will include the registration and all associated social event tickets (including additional purchases). Registrations are individual and cannot be shared.

NON-ATTENDANCE/NO SHOWS

No refund will be made for non-attendance at the Conference or social events.

CANCELLATION OF THE REGISTRATION BY THE DELEGATE

All cancellations must be made in writing to the Conference organising committee at conference@sarrah.org.au.

Full Conference or one-day-only cancellations:

If you have registered for the Conference as a full or a day Delegate, you are entitled to a refund if the cancellation is received on or before Friday 20 September 2024. All cancellations will incur a \$100 administrative fee. Cancellations received after this date will not be eligible for a refund. PRIVACY STATEMENT

SARRAH 2024 is required to comply with the requirements of the Privacy Act 1988 (Cth) (Australia). The Conference will collect and store information you provide in the Registration Form for the purposes of enabling us to:

- register your attendance at the Conference;
- assist with administrative and planning purposes;
- plan and develop the Conference and other events in the future;
- facilitate your requirements in relation to the Conference; and
- allow the compilation and analysis of statistics relevant to the Conference.

The information that you provide in the Registration Form and information provided at any other time during the Conference, including without limitation any feedback obtained during the Conference, will be used by the Conference to offer, provide, and continue to improve future events and other services.

At time of registration, delegates will be signed up to SARRAH Circle, the dedicated portal for the Conference. Delegates are responsible for the setup of their own delegate profile on SARRAH Circle for interaction with other delegates, sponsors, and exhibitors. Registered delegates will be able to set their privacy preference when they log in.

DISCLOSURE OF PERSONAL INFORMATION TO THIRD PARTIES

The Conference may disclose some of the information that is collected in the Registration Form such as your name, position and organisation to Conference sponsors and exhibitors. The Conference will not otherwise, without your consent, use or disclose your personal information for any purpose unless it would be reasonably expected that such purpose is related to the offer, provision, and improvement of the Conference or where such purpose is permitted or required by law. Delegates will be asked to provide disclosure of their contact details to sponsors or exhibitors during the registration process.

Intellectual property use

By registering for this Conference, all delegates grant permission to the Conference, the hosts, and its agents, to take photographs at the Conference to reproduce and to distribute on social media, promotional materials, and other association publications, whether in print, electronic, or other media, including the Conference website. By participating in the Conference, you permit the association to use, reproduce and distribute photographs/screen shots taken of you for such purposes and waive your legal rights to pursue any cause of action against SARRAH 2024 related to such photographs.
